



Suitable for direct employees, as well as the supply chain, lone workers and visitors, SkillGuard is the number one choice for organisations wanting to deliver:







About SkillGuard

SkillGuard combines a powerful, secure database and a high capacity, encrypted individual smartcard (physical or virtual), providing a single, transferable record for every worker. This ensures up-to-date, realtime validation of an individual's authority to work today, helping to maintain - or exceed - safety targets. SkillGuard is scalable with no limit on the number of individual records held or how much information can be stored against them, enabling our clients to manage their entire workforce in one trusted system. This is why SkillGuard is the leading system for enterprise-wide solutions and is the technology of choice for major clients requiring the power and flexibility that SkillGuard delivers. The SkillGuard hosted database is accessed via the internet and holds a comprehensive record of each individual worker. Data stored covers any relevant information that can be used to provide real-time "authority to work". Typically, this includes: a wide range of competencies, qualifications and training; summary occupational health data including date of last medical and D&A tests; job roles; recent activity on site; industry cards and other accreditations; current employment, sponsorship and other company association relationships.

The record also includes a full audit of every card check and swipe activity, which can be extensively filtered for management analysis. Therefore, the system also has a major role to play in the management of fatigue, providing a full record not only of hours on site but also travel time for the full fatigue profile.

Virtual Cards and Messaging

SkillGuard provides workers with virtual smartcards in a secure digital wallet on their smartphones. Virtual cards offer numerous advantages over physical cards: they are more convenient for the worker; more cost-effective for the employer and more sustainable for the environment as they help you eliminate plastic and electronic waste. Virtual cards also create a direct line of communication between your organisation and your workforce (including your supply chain) in the form of SkillGuard's integrated messaging module.

SkillGuard Messaging enables you to send targeted messages directly to the workers who need to receive them, regardless of their position in your employment or supply chain. Choose from messaging entire communities to selecting highly specific cohorts (e.g. with a specific competence or job role or based on work location).

Message creation is simple with highly attractive layouts automatically handled for optimum IOS and Android user experience. Messages can be prepared and sent in minutes, enabling clients to engage with their workforces strategically and rapidly.

As SkillGuard has so much valuable information about your workforce, the system can marshal this to help you communicate with your workers, even making it possible for them to respond to your message via links or buttons, and for you to analyse this data to optimise on both communications and corporate assurance.

- Site-delivered events inductions, briefings and toolbox talks – are captured electronically.

- Power BI reporting unlocks the data held in the SkillGuard system for powerful multi-dimensional analysis with dashboards and embedded reports.



Who Uses SkillGuard?

SkillGuard is used by a wide range of major organisations and across entire industries - in both the public and private sectors - to protect their workforces.

The system is often implemented under a different brand-name. For example, all of the following are also SkillGuard systems:

- HS2 Validate
- Highways Passport
- Thames Water Safety Passport
- Tarmac OneCard
- The Rail Industry Worker Programme (RIW) in Australia.

SkillGuard is designed as an enterprise solution and its principal benefits are derived when it is implemented across an organisation or industry, not just an individual project or site. This is because a major functional advantage is in the powerful transfer of the worker record as the workforce moves around from project to project. Also, cost benefits are realised to a far greater degree when implemented at scale, eliminating duplicate training or occupational health events as well as underpinning safety to a higher degree. This typically results in a significant reduction in AFR/LTIFR and an increase in overall efficiency.

What Do we Need to Implement SkillGuard?

SkillGuard is an online system securely hosted by Reference Point in the Microsoft Azure Cloud. Monitoring of the service is 24/7 with an uptime of 99.5% (plus occasional planned maintenance).

So all that is required is a device with internet access and a current web browser.

Tested browsers are: Microsoft Edge; Google Chrome; Apple Safari.

As well as the online database, individual workers have a smartcard (physical or virtual), and these can be securely read in a variety of ways. Most commonly, the cards are read using either the dedicated Android or iOS apps:

- For the Android app, Android v6 or above and a rear-facing camera (NFC is an option).
- For the iOS app, iOS v12 or above and a rear-facing camera (NFC is an option).

There is also an HTML5 (Web Card Reader) option for tablet devices with a rear-facing camera. All that is needed to use this is internet access and a current web browser from the above list.
